These projects set a standard for excellence, giving urban space new meaning as a platform for artists, while engaging diverse audiences and making culture accessible to all. The **Senior Curator** collaborates closely with the Artistic & Executive Director, curatorial colleagues, artists, project management, consulting, and communications teams, and other Public Art Fund staff in the development, production, and installation of exhibitions and programs, including commissioned works. As a member of the senior staff team, the **Senior Curator** contributes to in the formulation, management and implementation of organizational goals and strategies. The **Senior Curator** reports to the Artistic & Executive Director.

Key Responsibilities

- Play a leading role in shaping the curatorial vision for future artistic programming by developing medium and long-term exhibition planning that reflects the organization's mission and strategic goals.
- Oversee artistic program and schedule planning, including calendar milestones, artist outreach, and internal coordination with other departments.
- Formulate and articulate compelling exhibition and public program proposals that are both conceptually strong and technically feasible.
- Execute all aspects of artistic program development and implementation at the highest professional standards, including research, writing, presentations, budgeting, and coordination with project managers and the consulting team.
- Develop agendas, presentations, and talking points for, and attend as needed, relevant board meetings.
- Generate concise and lucid texts for various applications including board materials, interpretive signage, website, educational materials, catalogs, and other publications.
- Collaborate on PAF consulting projects including curatorial strategies, artist selection, and artist relations.
- Supervise the Associate Curator of Public Practice and Assistant Curator, plus additional curatorial positions and exhibition support staff as the team continues to grow.
- Participate actively in development efforts, including donor cultivation, fundraising strategies, grant applications and special events.
- Collaborate on communications and marketing to ensure effective planning and messaging including developing and reviewing content for press and marketing materials and participating in media and press events.
- Create and foster effective working relationships with a wide range of external PAF partners.

• Maintain a high level of personal involvement in the art community and strengthen key relationships with artists, collectors, curators and other colleagues.

The role of **Senior Curator** is a full-time exempt position.
